Creating Awareness for CSC:

The MV-1 is the only factory-built wheelchair-accessible ADA-compliant vehicle in the world and diversifies CSC’s fleet of vans. The goal of this program is to raise the physical activity levels of each participant to the level recommended by the Centers for Disease Control and Prevention (CDC). CSC is excited to work with the USABA and Anthem again this year towards lowering the obesity rate of people who are blind or have low vision by increasing each participant's physical activity levels.

CSC's Olympic Day will be held during the Winter Sports Camp February 5th – 7th, 2016. Some activities for the Winter Sports Camp weekend include goalball at the Chardon YMCA, snowshoeing at Highbrook Lodge, ice skating at The Pond in Bainbridge, and skiing at Alpine Valley in Chesterland. - A representative of the agency's insurance company was at CSC on December 21st for a Loss Control visit to update and gather information specific to operations relative to controlling property and general

liability losses. The representative toured the building and reviewed various systems including electrical, roof, heating, sprinkler and fire protection among others. As has been the case in the past, CSC is far above average relative to housekeeping and preventative maintenance practices and no recommendations for improvement were offered. - Every January 4th is celebrated as World Braille Day to honor Louis Braille and to recognize the importance of his invention, the Braille system. Louis was born in France in 1809 and lost his sight at age three as a result of an eye injury. However, Louis overcame this disability and went on to be a devoted and high-achieving student. As a student, Louis struggled with the limited modes of reading and writing available to the blind and partially sighted. These limitations to his independence as a scholar encouraged Louis to invent a new system for reading and writing for the blind. He created a simplified yet versatile coded system, using raised dots to represent numbers and letters, that we now call Braille. To learn more about Louis Braille, [click here](#).
- A new device to monitor the health and well-being of guide dogs has been developed. The prototype, developed by researchers at North

Carolina State University, comprises a high-tech harness – similar to the style used by handlers of guide dogs – that monitors a dog’s breathing and heart rate. The information is then disseminated to the owner through a vibration on the device. [Click here](#) for the full article.
