### In Memoriam: Mary Kay Howard, PhD

 Mary Kay Howard, PhD passed away May 31<sup>st</sup>, 2017. Beloved sister of Marion Nelle Howard, devoted aunt of niece Katherine and nephew Jeffrey, and cherished daughter of Marion K. and W. Rush Howard (both deceased). Mary Kay Howard was a History Professor at John Carroll University in University Heights, Ohio and a lifetime Member of the Board of Trustees of Cleveland Sight Center.

In 1977, Mary Kay Howard was named Handicapped Professional Woman of the Year for Outstanding Achievements. She was active in her religious community until her death. #### Ohio Secretary of State Jon Husted Visits CSC to Present IACA Merit Award:

Ohio Secretary of State Jon Husted and some of his staff members visited CSC on Wednesday, May 31<sup>st</sup> to visit the Call Center and present the IACA Merit Award to CSC. The International Association of Commercial Administrators (IACA) recently honored Ohio Secretary of State Jon Husted's Office with the 2017 IACA Merit Award. Ohio was one of only three jurisdictions worldwide chosen for the prestigious award and was recognized for the significant improvements to the Business Services Division Call Center and customer service by partnering with Cleveland Sight Center in January of 2016. Since working with CSC's Call Center, the number of calls handled per month has gone from 8,000 to more than 12,500 with a 95 percent customer satisfaction rate. #### CSC Receives Grant from the Kelvin and Eleanor Smith Foundation:

• This past fall, Cleveland Sight Center was awarded a \$30,000 grant from the Kelvin & Eleanor Smith Foundation to be used for general operating support. CSC has been notified by the construction group working on the west side of E. 101st Street of some upcoming changes to pedestrian traffic flow along Chester Avenue in front of Innova, which will affect pedestrian traffic to and from the apartment building and restaurants at that location. Barricades and signage will direct pedestrians to cross Chester to the south side of the street, travel east to E. 100th Street where they can cross back to the north side of Chester.
