### Creating and Strengthening Partnerships:

- Alexis Vinick, Paul Rosenberg and Joel Zureick participated in the Community Rehabilitation Provider conference hosted by Opportunities for Ohioans with Disabilities (OOD) on Tuesday, July 28<sup>th</sup> at the Parma-Snow Library in Parma, Ohio. Other participating organizations that provide rehabilitation services included United Cerebral Palsy of Greater Cleveland, Koinonia, Vocational Guidance Services, LEAP and VocWorks. OOD announced that the State of Ohio has already met its employment goals for the fiscal year ending September 30, 2015 and that the average time from a consumer’s referral to the determination of eligibility for OOD services has been reduced to 37 days. Alexis and Paul reported to the group CSC’s recent employment outcomes, a review of CSC’s unique services and an update on the collaborative work with Ohio Means Jobs of Cuyahoga County, Westfield Insurance and Lubrizol Corporation.
- On Thursday, July 30<sup>th</sup>, Employment Services welcomed Shannon Monyak, Director of Programs at Services for Independent Living. Ms. Monyak was the guest speaker at the July Job Club, which is run monthly by Nicole Kahn, and provided many tips and strategies to help our consumers prepare for job interviews and pass employee screening assessments. Consumers in the group shared their own stories about recent job interviews and Ms. Monyak fielded questions regarding ways to discuss job accommodations with employers and make a positive first impression. She has worked with individuals with disabilities, promoting independence and community participation for more than eight years. She has additional experience conducting vocational training in computer and retail settings, designing and

managing assistive technology and accessible computer labs and providing support for high school youth with disabilities transitioning from school to post-secondary education.

- The [Northeast Ohio Areawide Coordinating Agency \(NOACA\)](#) has created the Northeast Ohio Mobility Coalition to focus on innovative solutions to transportation issues that face individuals with disabilities, seniors, individuals with low income and those who need transportation for health care. ### CARF Corner:

- **Rights of Persons Served.** To ensure that the persons served have a clear understanding of their rights, the organization communicates and shares these rights in a manner that is understandable to the person served. Rights of the person served should be communicated to the person served in a way that is understandable; prior to the beginning of service delivery or at initiation of service delivery and annually for persons served in a program longer than one year.
- The following is a significant highlight in CARF history:

#### **January 2014**

CARF introduced standards for Cancer Rehabilitation Specialty Program in the Medical Rehabilitation accreditation area. New standards for Peer Support Services were also published in the

Behavioral Health, Child and Youth Services, Employment and Community Services, and Opioid Treatment Program standards manuals.

**December 2014**

CARF Europe opened office space in London, England, United Kingdom.
